Under the CARES Act passed by Congress, the Small Business Administration is providing small businesses with 2 loan opportunities, the Payroll Protection Progrmam and the Emergency Economic Injury Disaster Loan. ### Tax Filing Deadline Extended



The Tennessee Department of Revenue has extended the due date for filing and paying the Hall income tax from April 15, 2020 to July 15, 2020.

Taxpayers will have until July 15, 2020, to file returns and make any payments originally due on April 15, 2020. Interest and late filing penalties will not be applied to returns filed and payments made on or before this extended due date. The October 15, 2020, six-month extension date for the calendar year 2019 return remains unchanged.

## Warning of Cyber Bullying

We recently had a member of the public reach out to our office with someone who is sending texts to him offering to buy his house. He's asked him to stop multiple times and has even threatened to call the police. If this ever happens to you it is described as Cyber bullying and the recommendation is to call law enforcement. Sending an annoying or alarming text message, for example, is a form of harassment under Tennessee law. If you or a client are experiencing this, contact the police to report the matter and the phone number.

#### TREC Licensing Renewal and Educational Reqirements

Due to COVID-19 TREC has put forth Executive Order 15, section 27. This executive order applies to all of those licenses that fall under the Department of Commerce & Insurance which includes Real Estate. This means that you will not be assessed a late fee if you can not renew your license due to not being able to get CE.
